Producer Price Index

Q3 2024

Prishtina 06.12.2024 Kosovo Agency of Statistics (KAS) has started to publish the Producer Price Index (PPI) in May 2009.

Prices and values of industrial products are collected from manufacturing enterprises with the most influence in Kosovo. Value of product and annual average price is referred to 2007, while since the first quarter of 2009 the index is monitored and calculated continuously in quarterly and annual periods.

PPI, or Producer Price Index is in accordance with the Standard Classification of Activities according to NACE rev.2, based on the "Regulation No.11/2013 Article 7, for the implementation of the Standard Classification of Activities. PPI is under construction and continuously seeks to include economic activities which currently are not active but gradually the product is expected from these activities.

Definition and the purpose of P9.10	,

Producer Price Index (PPI) for the Third quarter of 2024

The price index for total manufacturing in Kosovo increase 6.9 % between between Q3 2024 Compared Q2 2024. Compared with Q3 2023 production prices ncrease by an average of 9.9%.

Third quarter 2024 - Second quarter 2024 6.9%

Producer prices in Kosovo increase by an average of 6.9% between Q3 2024 and Q2 2024. Largest increase by economic activity is noticed to: supply of electricity, gas, steam and air conditioning (20.1%), other ores and quarries (7.8%), manufacture of furniture (7.5%), production of metals (3.9%), manufacture of fabricated metal products, except machinery and equipment (3.2%), manufacture of wood and of products of wood and cork, except furniture, manufacture of articles of straw and plaiting materials – plating (2.9%), manufacture of rubber and plastic (1.5%), manufacture of machinery and equipment p.k.t. (1.4%), manufacture of leather and articles therof (0.9%), manifacture of beverages (0.4%), and production of food products (0.3%).

The increase was neutralized by the decrease in prices to: mining of metal ore (-15.0%), manufacture of motor vehicles (transport), trailers and semi-trailers (-12.9%) and production of non-metallic mineral products (-0.5%).

Third quarter 2024 - Third quarter 2023 9.9%

Producer prices in Kosovo increase by an average of 9.9%, between Q3 2024 and Q3 2023. The largest increase by economic activities were: supply of electricity, gas, steam and air conditioning (26.6%), manufacture of paper and articles of paper (11.2%), manufacture of wood and of products of wood and cork, except furniture, manufacture of articles of straw and plaiting materials — plating (10.9%), manufacture of machinery and equipment p.k.t. (10.5%), mining of metal ore (9.5%), manufacture of leather and articles therof (8.8%), production of metals (8.1%), production of food products (6.1%), other ores and quarries (5.8%), manufacture of chemical products (4.4%), manifacture of beverages (3.6%), collection, treatment and supply of water (3.5%), manufacture of fabricated metal products, except machinery and equipment (3.1%), manufacture of furniture (2.2%), manufacture of rubber and plastic (1.6%) and production of non-metallic mineral products (0.7%).

The increase was neutralized by the decrease in prices to: manufacture of motor vehicles (transport), trailers and semi-trailers (-17.8%) and manufacture of electrical equipment (-8.0%).



Methodological explanations

Definition and the purpose of PPI

Producer Price Index (PPI) is a relative indicator that measures the degree to which prices of goods (products) produced and services vary in a certain period of time. This index is the statistical key for decision making process on economic policy, business and monitoring the inflator and deflator parameters. As a statistical parameter, PPI has a special significance for the estimation (calculation) of the Gross Domestic Product by production approach.

Methodology

Prices and value of industrial products are collected from the most representative manufacturing enterprises in Kosovo. Value of products and average price are for Q1 2007, while since Q1 2009 the collection is made in regular quarterly bases.

Due to comparability of data with Eurostat, with the decision of the Government of the Republic of Kosovo, the Kosovo Statistical Agency from 01.09.2014 has started using the new nomenclature of economic activities (NACE Rev.2) based on the "Regulation No.11/2013 on the implementation of standards for the classification of activities" therefore the Producer Price Index has changed in accordance with this nomenclature.

At the same time the core index has changed moving from base year 2007=100 in base year **2010=100**. Sections 12,13,14,18, 21, 32 and 38 take part in the calculation of the Index, but because prices for these sections have started to be collected after 2010 and they lack base index 2010=100 of which later will create base index and will calculate the following indicators.

Since 2024, PPI is calculated for 26 Sections (economic activities), about 192 Manufacturing enterprise over 800 items. As a project (GOPA - KAS) has started in 2007 in order to create the basis for establishing the PPI survey, while since the mid-2010 project is being supported by Swedish SIDA.

PPI from first quarter 2024 uses specific weights updated from the data of the Structural Business Survey (SBS), 2022.

For the calculation of PPI is used the Laspeyres formula.
