GLOSSARY OF TERMS

Key topic definitions-general variables

Census

An official counting process conducted by a country at a specific time for the entire population (persons) by collecting demographic, economic, social, educational, agricultural and other information about each person. The census in Kosovo was conducted through a face-to-face interview where data was collected for each household/individual.

Resident population

Population corresponds all persons who usually resided in Kosovo for at least 12 months at the census date, or who intend to reside for such a period.

Non-resident population

Persons who usually reside outside Kosovo, but temporarily within Kosovo for purposes such as work, studies, tourism or family visits. By international standards, these persons are not included in the statistics of the resident population of Kosovo, but may be enumerated for specific statistical purposes such as the assessment of migration flows, economic analyses and studies on public services provided to this category.

Household

A household comprises all persons living in the same dwelling who share their main means of subsistence. Household here refers to the concept of private household, by opposition to collective households such as religious congregations, health centres, orphanages, etc.

Institutional household

Institutional households include persons who need shelter and subsistence, which is provided by an institution. An institution is understood to be a legal body for long-term residential purposes that provides services to a group of persons. Institutions usually have common facilities that are shared by the residents (bathrooms, living rooms, dining rooms, bedrooms, and so on).

Institutional households are grouped into the following categories:

- student residences/dormitories,
- hospitals,
- sanatoriums,
- nursing homes,
- facilities for the disabled,
- psychiatric institutions,
- nursing homes,
- children's homes,
- orphanages,
- military and police barracks,
- prisons and correctional facilities,
- monasteries,
- workers' homes,
- refugee camps,
- others (including assisted living facilities and welfare institutions). Institutional households are generally located within collective housing quarters.

Family

Two or more persons living together linked with family ties of first grade, such as

- a couple with or without children or a
- lone-parent with at least one child; in the census definition, a grand-mother with a grand-child, or two brothers without parents are not considered a family.

Housing unit, also called Dwelling

An independent structure containing one or more dwellings, rooms or other spaces, covered by a roof and enclosed within external walls, or dividing walls which extend from foundations of the roof, whether designed for residential, agricultural, commercial, industrial, cultural purposes or for the provision of services.

Urban

An urbanized geographical area - defined at settlement level - characterized by higher population density and vast human features in comparison to surrounding areas. In Kosovo census an area is defined as urban by administrative decision of the municipality.

Rural

A not urbanized geographical area - defined at settlement level - characterized by lower population density, and typically where much of the land is devoted to agriculture in comparison to surrounding areas. In Kosovo census an area is defined as rural by administrative decision of the municipality.

Population aged 1 year and over

Definition used for all variables relating to the respondent's situation one year or more before the census; ex. Place of usual residence one year before the census cannot apply to babies born during the last year.

Population aged 15 years and over

Includes all individuals who had reached the age of 15 on the date of enumeration.

Main characteristics of buildings

Residential building

Building designed for habitation.

Detached house

Individual house not attached to any other building.

Semi-detached house

Two attached houses.

Row or string of houses (with at least 3 connected or adjacent dwellings, each with a separate exit to the outside)

Buildings that have three or more apartments in a row, each of which has a separate exit; Apartment buildings or blocks are blocks of apartments that have three or more apartments that have a common exit;

Non-residential building

Non-residential building consists solely or mainly of one or more units designed for agricultural, commercial, or service purposes, such as: mosque, church, factory, etc.

Number of floors of a building

The number of floors is counted from the ground floor upwards, including the ground floor (the ground floor is counted as floor number one).

Year of construction of the building

The year when the building was completed or, if any, the year when major constructional changes were finalized. For a completed dwelling, which is located in an uncompleted building, the year in which the construction of the dwelling was completed is entered.

Main characteristics of the dwelling /housing units**Collective housing quarter (collective housing)**

Collective living quarters include structurally separate and independent places of abode intended for habitation by large groups of individuals or several households and occupied at the time of the census. Such quarters usually have certain common facilities, such as cooking and toilet installations, baths, lounge rooms or dormitories, which are shared by the occupants. Collective living quarters may be further classified into:

- (a) Hotels, rooming houses and other lodging houses;
- (b) Institutions;
- (c) Camps.

Conventional dwelling

A room or suite of rooms and its accessories (lobbies, corridors etc.), in a permanent building or structurally separated part thereof which is designed (or converted) for permanent habitation, such as a house or apartment. It has to be surrounded by walls and covered by a roof and it has to have direct access from the street or from a public or communal staircase, passage, gallery or grounds (i.e. when the occupants can enter and leave without passing through another household's accommodation).

Non conventional dwelling, or Other type of housing unit

Housing unit which is:

- mobile (e.g. a tent or a caravan),
- semi-permanent (e.g. a hut or a cabin),
- improvised (e.g. a shuck or a shanty) or
- not designed for human habitation (e.g. a garage, a shop, a natural shelter) but which is used at the time of the census as the usual residence of one or more persons.

Homeless

People with no shelter (sleeping rough) or with no place of usual residence who move frequently between various types of accommodations.

Inhabited dwelling (also called Occupied dwelling)

The dwelling is inhabited by persons belonging to the census population (housing unit where one or more persons are usually living), regardless of whether or not they were temporarily absent on census day.

Reserved for seasonal/occasional stay or secondary use

The dwelling is used only for holidays; summer season; seasonal work; or any other occasional stay. It is however not a principal usual residence.

Dwelling for business purposes (ex. law firm, medical office, etc.) Dwellings used for business purposes at the time of census.

Vacant dwelling - A dwelling is described vacant if it has no usual residents at the time of the census but is available to become the usual residence of at least one person (for example dwellings vacant for rent or for sale, and dwellings of households working abroad, if nobody lives in them).

Number of households living in the housing unit - the number of households living in a housing unit.

Number of persons with usual residence in the housing unit: persons with usual residence in this housing unit. **Number of rooms available including rooms for business or professional purposes**

Room

Spatial unit of a dwelling intended for living, separated from the other rooms by stable walls (reaching from the floor to the ceiling or roof covering), at least to a height of 2 meters above the ground, of a size large enough to hold a bed for an adult (4 square meters at least) and at least 2 meters high over the major area of the ceiling. Therefore,

- Normal bedrooms, dining rooms, living rooms,
- Habitable cellars and attics,
- Kitchens and other separate spaces used or intended for habitation are counted as rooms (if they correspond to the above mentioned definition).

On the contrary,

- A kitchenette (i.e. a kitchen of less than 4 square metres),
- verandas, utility rooms (e.g. boiler rooms, laundry rooms) and
- lobbies are not counted as rooms; nor do bathrooms and toilets (even if they are more than 4 square metres).

Rooms separated from the dwelling but functioning with it and usable by the household are considered part of the dwelling and are included in the total number of rooms.

Rooms, including rooms for business and professional purposes

Rooms of a dwelling intended for living together with rooms of the housing unit used for business or professional purposes.

The main water supply system in the dwelling unit is the difference between dwellings that have or do not have a water supply system through the water supply system.

Piped water from a public service

The water is piped (comes from taps) and distributed by a community provider (example the municipal water supply system).

Piped water from non-public sources

The water is piped (comes from taps) but is not distributed by a community scheme. This is the case where water is pumped into the house through a pipe from a well (especially in rural areas) or from a natural waterfall (especially in mountain areas)..

Piped water within the building but outside the dwelling

Access to the water is outside the housing unit and might also be shared with other dwellings within the building.

Piped water outside the building

Access to the water is available only outside the building.

No piped water available

There is no piped water available at all (neither in the housing unit nor outside the building).

Wastewater discharge through sewerage connected to the public system,

Households whose dwelling has wastewater discharge through a sewerage system connected to a public system.

Wastewater discharge through sewerage connected to the private system,

Households whose residence has wastewater discharge through a sewerage system connected to a private system.

All other means (ex. canal, septic tank, river, etc.),

Wastewater is not discharged through the sewage system, but into canals, septic tanks, rivers, etc.

There is no sewage system

When the dwelling does not have a sewage disposal system, especially in rural areas.

Flush toilets inside the dwelling

The dwelling has a flush toilet inside the housing unit.

Flush toilet outside the dwelling but in the building

A flush toilet is available within the building but outside the housing unit. Access to the toilet might also be shared with other dwellings within the building.

Flush toilet outside the building

Access to a flush toilet is available only outside the building.

No flush toilet available

There is no flush toilet available (especially in rural areas) and dry toilets (so-called 'latrines') might be used.

Fixed bath or shower

Access to at least one fixed bath or shower available in the dwelling.

No fixed bath or shower

There is no bath or shower available in the dwelling.

Kitchen

A kitchen of at least 4m² is available in the dwelling.

Kitchenette

A kitchen smaller than 4 m² is available in the dwelling.

Cooking facilities provided in another type of room

For example, places where people cook on a wooden stove placed in a living-room.

No cooking facilities

There is no cooking facilities at all in the dwelling.

Central heating from a public heating centre

Central heating provided for residential units which are supplied centralized heating distribution system.

Central heating from an installation in the building or in the housing unit

Independent central heating boiler within the dwelling or within the building.

Stove

A portable or fixed apparatus that furnishes heat for warmth, cooking, etc., commonly using coal, oil, gas, or wood as a source of power.

Fireplace

The part of a chimney that opens into a room and in which fuel is burned or any open structure, usually of masonry, for keeping a fire.

Portable electric heater

A portable apparatus that furnishes heat for warmth and uses electricity as a source of power.

Other types of heating

For example solar heating system.

No heating at all

There is no heating system available in the dwelling.

Main type of energy used for heating

In case more than one sources of energy is used, the most commonly used is reported.

Main household arrangements**Household member**

Any person usually resident in the household.

One-person household

A person who lives

- alone in a separate housing unit or
- who occupies, as a lodger, a separate room (or rooms) of a housing unit but does not join with any of the other occupants of the housing unit to form part of a multi-person household.

Multi-persons household

A group of two or more persons who may or may not be related to each other and who combine to occupy the whole or part of a housing unit and to provide themselves with food and possibly other essentials for living. Members of the group may pool their incomes to a greater or lesser extent. A household can consist of one or more families.

Non-family household

A dwelling where

- a person lives alone or shares it exclusively with unrelated people or
- people not belonging to a family according to census definition, for example, roommates or unmarried partners, brothers, etc.

One-family household

A household composed of only one family.

Families by composition**Husband-wife family, partners with marriage certificate**

A family where at least a legal couple husband-wife is present, with or without children.

Husband-wife family, partners without marriage certificate

A family where at least an informal couple husband-wife is present (not legalized union), with or without children.

Lone father family

A family where the parent is a male, without partner but with at least one child.

Lone mother family

A family where the parent is a female, without partner but with at least one child.

Families according to children**Without resident children**

A couple husband-wife (legalized union or not) living without any of their children.

With at least one child aged less than 25

A couple husband-wife (legalized union or not) living with at least one of their children whose age is lower than 25 years.

With youngest child aged over 25

A couple husband-wife (legalized union or not) living with at least one of their children, the youngest of them being aged 25 years or over.

Head of household

The person who was declared as the reference person in the household. Ties of all other household members are given in relationship to this person. For example, if the head of household is «Mr White», his partner living with him will declare herself «wife of Mr White»; his male sibling living with him will declare himself «brother of Mr White» and the wife of this sibling shall declare herself «sister-in-law of Mr White».

Family status

The position of a person in an existing family, depending on its partner or hierarchical relationship: ex. Husband; Wife; Child; Lone parent; etc.

- Husband-wife with marriage certificate
- Husband-wife without marriage certificate (coexistence)
- Single parent without a partner in the family
- Single parent with partner living outside Kosovo
- Child of both parents
- Child of male partner
- Child of female partner
- Children with a single parent
- A person who does not belong to any family.

Age

Age is counted in completed years; ex. Persons of age 25 comprise all persons who already celebrated their 25th birthday at the census date; new-born children who did not reach the first birthday are aged 0.

Relationship to the head of household**Husband-wife with marriage certificate**

Husband or wife of head of household, with legalized union.

Husband-wife without marriage certificate

Husband or wife of head of household with non-legalized union (de facto union socially recognized as a marriage).

Partner

Partner of the head of household living together.

Son/daughter

Son or daughter of the head of household.

Son-in-law/daughter-in-law

Son-in-law or daughter-in-law of the head of household.

Father/mother

Father or mother of the head of household.

Father-in-law/Mother-in-law

The father-in-law or mother-in-law of the head of the household.

Brother/sister

Brother or sister of the head of the household.

Grandson/granddaughter

Grandson or granddaughter of the head of household.

Other relative

Other relative of the head of household; ex. grandparent, uncle/aunt, brother-in-law/sister-in-law, nephew/niece, cousin, etc.

Other relative

Other relationship to the head of household, e.g., partner, stepfather, stepmother, etc.

Not a relative

The household member is not at all related to the head of household; ex. Friend, host, servant, home-health aid, person under custody, etc.

Main characteristics of households

Tenure status

The arrangement under which the household occupies the housing unit.

Other form of tenure

The household occupies all or part of the housing unit under some other form of tenure; ex. when the housing unit was provided to the household free of charge by an employer or by a relative.

Land in ownership or in use

All land surface either in ownership or in use by the household; the land recorded is not necessarily located in the same municipality where the household lives, it can be also located in another municipality in Kosovo.

Main characteristics of persons**Biological sex**

Term used to describe the physiological and genetic characteristics that determine whether an individual is biologically male or female.

Ethnic background

Reference to the identity of a group of people whose members identify with each other through a common heritage, consisting of a common culture and customs, including a shared language or dialect.

Religion

Collection of cultural systems, belief systems, and worldviews that relate humanity to spirituality and, sometimes, to moral values.

Mother tongue

The first language a person has learned from birth and is still able to speak.

Country of citizenship

The State with which an individual has a particular legal bond, acquired by birth or naturalization, whether by declaration, option, marriage or other means according to the national legislation.

CHAPTER 1

BACKGROUND INFORMATION

About the Census

The Population Census (hereinafter: “Census”) is a comprehensive statistical process, which involves the collection, analysis and publication of data within a given territory. This process, usually conducted every ten years, is an important moment for every country, as it provides an accurate picture of the demographic, economic and social situation of the population.

The Census collects detailed statistical data on:

The number of population: To estimate the size and distribution of the population at national, regional and local levels.

Demographic characteristics: Data on age, gender, marital status and family composition.

Economic and social characteristics: Information on the education, employment and economic level of individuals and families.

Household and housing conditions: Data on living conditions, housing typology and available infrastructure.

These data are irreplaceable, as they create a solid basis for further studies on population dynamics, and policymaking at the national and international levels.

The Census represents one of the oldest and most complex methods of collecting statistical data. It includes every individual and household unit within the territory of a state, which makes the Census unique compared to other statistical methods, as it provides a comprehensive overview of the population and creates a reference point for subsequent demographic assessments and forecasts.

The Population and Housing Census in Kosovo (hereinafter: CeKos) for the year 2024, conducted in the period 5 April - 24 May 2024, represents a key point in the statistical development of the country.

This is the second Census after the declaration of Independence of Kosovo and the first Census to be conducted fully in digital format, contributing to the collection and analysis of data with advanced technological standards.

The Critical Moment in the Census is a fundamental concept that defines the specific time that serves as a reference point for the collection of population and housing data, representing a specific moment in time when all census data are considered to be valid and collected in accordance with the factual situation. The choice of this moment is important to ensure that the information collected is accurate, consistent and comparable. This moment is key because it eliminates uncertainties that may arise from ongoing demographic changes, such as births, deaths, migrations and internal movements. CeKos 2024 represents the demographic and socio-economic picture of the resident population in Kosovo. The reference moment or critical moment of this picture was determined at midnight between 04-05 April (2024).

Objectives of the Census

Census is an essential process in the administration of a state and the fulfillment of the socio-economic needs of society. This process constitutes a rich source of demographic, economic and social data that help in the creation of evidence-based public policies and are essential for the fair distribution of resources and for sustainable development planning at local and central levels.

The 2024 Population Census in Kosovo represents one of the most important statistical undertakings of the country, focusing on providing accurate and up-to-date data on demographic, social and economic aspects of the population, and housing conditions.

In the framework of the 2024 Population Census in Kosovo (CeKos 2024), providing accurate and up-to-date data was one of the main priorities. This component was vital to ensure that political decisions, public investments and development programs are based on reliable and accurate information.

The Census constitutes a very important source of statistical data, which will serve for the design of evidence-based policies by helping in the fairer distribution of public resources in accordance with the different needs of the population, ensuring a more efficient and equitable division between the local and central levels.

Another important objective of the 2024 Census was to assess the demographic situation since the last census in 2011. This component is essential to observe changes in the composition and distribution of the population, including migration trends, changes in household structure and age dynamics. Knowing these changes is vital to face new social and economic challenges that come with time.

Another important aspect was the harmonization of Kosovo statistics with international standards. This included the application of advanced statistical methodologies and the following of best practices in accordance with the recommendations of international institutions, such as the United Nations and Eurostat. Alignment with these standards ensures international comparability of data and helps strengthen Kosovo's capacity to be a reliable partner in the international arena.

The 2024 Census also aimed to increase Kosovo's capacity to collect and manage statistical data in digital format. By advancing towards the digitalization of statistical processes, it aims to improve the efficiency and accuracy of data collection, as well as reduce administrative costs. This constitutes an important step towards modernizing the country's statistical system and aligning it with global trends in the use of new technologies in the field of statistics.

From what has been said, the 2024 Census represents an important strategic activity for the development of Kosovo. The data collected will play a key role in the evidence-based policy-making process, helping in the fair distribution of resources and sustainable development planning at all levels of government. In an increasingly complex global and local environment, the 2024 Census marks a necessary step towards improving the management of the country and the well-being of its citizens.

Legislation

The Law on Population and Housing Census provided the objectives, responsibilities, methodology, definitions, and institutions to be involved.

The legislative framework of the 2024 Census was drafted taking into account the standards set by the United Nations and European best practices, aligning with the recommendations of Eurostat, the United Nations Economic Commission for Europe (UNECE), and the United Nations Population Fund (UNFPA). Alignment with these standards has ensured that the Census is

comparable with other censuses in the region and beyond, ensuring quality and coherence in the data collected.

The Census Law has set clear objectives aimed at collecting accurate and detailed data on population and housing conditions. The legal objectives have ensured a focus on meeting the country's needs for statistical data, which will serve for strategic planning, resource allocation and public policy formulation.

The legal framework has clearly defined the role and responsibilities of the Kosovo Agency of Statistics (KAS) as the main body for conducting the census. The law has also created a basis for inter-institutional cooperation between KAS and other state institutions, including municipalities, the Ministry and other bodies. This coordination has been key to the efficient management of the process.

The legislative framework has served as a roadmap for the budget, ensuring a clear division of financial responsibilities.

Also, a crucial aspect of the legal framework has been the protection of citizens' personal data, in accordance with the Law on the Protection of Personal Data and international standards such as the General Data Protection Regulation. This component has ensured that the data collected during the census are secure and used only for statistical purposes.

Another important element has been the inclusion of a mechanism for open and continuous communication with citizens.

The legal framework has created the basis for the observation of the Census process by national and international institutions, ensuring an independent assessment of the quality and correctness of the census. This has significantly increased the credibility of the final results.

Funding the Census project

The Census project cost was to be around 10.7 million euros, which was mainly covered by the Kosovo budget (98.5%). Support from international donors, including Eurostat, UNFPA and the World Bank, was also important for specific activities such as methodology, training and outreach campaigns. With an estimated budget of 14.9 million euros, this project required a well-structured and effective approach to financial management to ensure optimal use of funds.

Brief background of the censuses in Kosovo

Population censuses are an essential practice to provide accurate demographic and economic data, which are essential for the planning and socio-economic development of a country. According to international standards, censuses should be conducted every ten years, as the demographic and economic changes that occur within this period are significant for the design

First censuses (1948-1981)

The first census in Kosovo was conducted in 1948 and subsequently again in 1953. Since then, censuses have been organized every decade: in 1961, 1971 and 1981. These censuses were conducted within the former Yugoslavia and provided data on population increase, structural changes and migratory trends, representing important sources of statistics for regional development.

Termination and non-fulfillment of Census (1991)

The Census in Kosovo was not conducted in 1991 due to systematic interference and repressive measures applied by the Serbian regime against the Albanian population. After the dissolution of Kosovo's autonomy in 1989, Serbia implemented a series of violent measures aimed at marginalizing Albanians from public institutions, including their massive dismissal from jobs in the administration and from the staff of the Kosovo Agency of Statistics. In this repressive

atmosphere, Albanians refused to participate in the census, seeing it as a means of legitimizing the Serbian regime in Kosovo.

Instead of a regular census, the Yugoslav Federal Office, based in Serbia, compiled biased estimates of the population of Kosovo. These data were not accepted by either Kosovo or international institutions, being considered inaccurate and politically motivated.

Post-war challenges and international recommendations (2001-2011)

After the war of 1998-1999, Kosovo went through a difficult period of reconstruction, making it impossible to organize a proper census until 2011 due to large population displacements and political uncertainty. Meanwhile, during the United Nations administration (1999-2008), the Census was planned several times, but was postponed until 2011 on the recommendation of Eurostat to ensure compliance with international standards and comparability with other countries in the region.

Census in 2011

After two decades without an official Census, Kosovo conducted its first proper Census on April 1, 2011. This Census marked a turning point for the young state of Kosovo, being the first Census to be organized independently after the declaration of independence in 2008. The process was conducted under the supervision and support of international institutions, ensuring respect for international standards for the collection and analysis of demographic data.

Census in 2024

The Population and Housing Census of Kosovo (CeKos), conducted between 5 April and 24 May 2024, represents a key point in the country's statistical system. This was the second Census after the declaration of Kosovo's Independence and the first Census to be fully implemented in digital format, contributing to the collection and analysis of data with advanced technological standards. This Census aims to correct the shortcomings of the past and provide accurate data for the sustainable development of Kosovo.

Planning and consulting

Census 2024 was planned with particular care, following international standards and including extensive consultations with stakeholders. This process was designed to ensure that the data collected were accurate, comparable with previous censuses and compliant with European Union standards.

The Census of 2024 was prepared in accordance with the Recommendations of the European Statistical Commission (ESC) and with the Regulation of the European Parliament no. 763/2008, which sets out the requirements for population censuses in the EU Member States. This harmonization ensures that the data collected from Kosovo are comparable with those of other European countries, meeting high standards of quality and accuracy.

In preparing the Census 2024, KAS has closely cooperated with a wide range of institutions, including ministries, international institutions such as Eurostat, non-governmental organizations and representatives of local communities. The consultations aimed to identify priority topics for the census, including core questions related to demography, education, migration and employment.

The topics included in the Census 2024 questionnaires have been carefully selected, taking into account national and international needs. The questionnaires include questions on household structure, housing conditions, migration, the socio-economic status of citizens and war damage.

The development of the Census 2024 questionnaires involved several interrelated phases, which were handled with the utmost care. A key aspect of the development of the questionnaires was the engagement of stakeholders. KAS collaborated with government agencies, ethnic and religious groups, non-governmental organizations (NGOs), as well as international organizations. This collaboration aimed to ensure that the questionnaire reflected the needs and interests of all users. In this context, KAS organized 87 separate meetings with data users, including also two events called "Census Week", each lasting five days. These activities were conducted with citizens and other stakeholders to ensure that everyone had the opportunity to provide their input.

The Census 2024 questionnaire was significantly improved compared to the last Census in 2011. Its content was expanded with 20% more questions and sub-questions, covering a wider range of topics. This increase in content aimed to provide more detailed and useful data for development policies and plans.

To ensure maximum inclusion and equal access for all population groups, the questionnaire was designed and distributed in Albanian, Serbian, Turkish and English. This multilingualism reflects the cultural and ethnic diversity of Kosovo, ensuring that each individual can complete the questionnaire in their preferred language.

The Census 2024 represents an important step towards fulfilling the conditions for EU membership. This process demonstrates Kosovo's ability to meet its international obligations and to provide reliable data that will assist in its socio-economic and political development. As such, Census 2024 is not only a technical process, but also a cornerstone for Kosovo's future on the European stage.

Planning and preparing

The planning for the Census began in 2019. This phase was accompanied by the creation of a working group, which aimed to oversee all aspects of the preparation, which included a wide range of measures and mechanisms that ensured a structured and comprehensive approach. This group was tasked with ensuring that the selected methodologies, logistical procedures and legal arrangements met the highest standards. The preparatory phase also focused on identifying potential challenges and preparing scenarios to address them effectively. Thus, the Census plan was not just an administrative effort, but a strategic operation, supported by a methodological approach based on scientific principles of project management.

In terms of methodology, the working group prepared detailed action plans addressing each activity.

Key planning components

Detailed Action Plan: one of the key components of the planning was the development of a detailed action plan. This plan, which included a comprehensive roadmap, was intended to guide activities in different sectors. This plan consisted of over 500 activities, divided into different units and sectors. Its flexibility was reflected in the continuous updates to reflect the changes occurring in the operational environment. A significant example of this flexibility was facing the challenges of the COVID-19 pandemic, which forced the review and adaptation of existing procedures in accordance with the new reality.

Risk management: was a key component in ensuring the success of the project. It involved the development of contingency plans to minimize the impact of any unforeseen challenges that could disrupt the process. This type of management became the basis for implementing tailored policies at each stage, ensuring that operations continued without interruption.

As the Census involved a large number of external challenges, specific strategies were developed to deal with emergency situations. Risk identification and assessment helped to anticipate potential challenges and design appropriate scenarios for each situation. These contingency

plans were designed to minimize the impact of unexpected events and ensure that the census process continued without interruption.

Pre-field tests and pilot enumeration:

Pre-field tests, field tests and pilot census are essential stages for the successful preparation and implementation of a national Census.

Pre-Field Tests

Pre-field tests were conducted within KAS to evaluate data collection applications, IT systems, and technical procedures. The main activities included:

- Development and testing of data collection applications using the CAPI method.
- Testing electronic devices for durability and performance in real-world conditions.

Field Tests

Field tests were conducted in randomly selected areas to reflect the demographic and geographical diversity of the country. Activities included:

- Training enumerators on the use of interview applications and procedures.
- Conducting field interviews to assess the fluency and duration of the interview process.
- Monitoring and supervising interviews to ensure the quality of data collected.

Pilot Census

The pilot census was conducted in a limited number of municipalities to simulate the census process. This process included:

- Complete data collection using the CAPI method.
- Real-time data collection and verification through integrated IT systems.
- Logistics and organization of distribution of equipment, materials and support staff in the field.
- Updated Digital Map to ensure accurate distribution of interview areas and assignment of tasks.
- Evaluation of results to identify any potential weaknesses in operational, technical and administrative procedures.

Methodology

KAS chose the CAPI methodology for the Census. This approach aimed to ensure high data accuracy and a standardized collection process, based on international best practices.

Face-to-face interviews and CAPI method

Face-to-face interviews were essential for data collection, allowing the enumerators to interact directly with the interviewees. This method ensured that each question was clearly explained and all responses were accurately recorded in the CAPI application.

CAPI technology enabled automatic data entry on electronic devices such as tablets and laptops, streamlining the process and reducing potential errors associated with manual recording. Data collected in the field were transferred in real time to secure central servers for verification and further processing.

The Role of Enumerators and Supervisors

The enumerators were responsible for collecting data in the field, and conducting interviews with citizens. They received specialized training on the use of the CAPI application and data collection protocols.

Supervisors were responsible for monitoring the performance of the enumerators and ensuring that quality standards were met. They conducted regular checks of the data collected and reported any technical or operational problems to the respective centers.

Control and Processing Centers (KAS)

The collected data was transferred to the KAS center for control and processing. This center was equipped with advanced technological infrastructure and specialized data processing teams, ensuring that every stage of the process was transparent and reliable.

KAS also developed several systems and dashboards for monitoring and identifying anomalies during the enumeration process. These systems helped detect deviations from expected data standards and enabled rapid interventions to correct errors or address technical issues in real time.

Awareness campaign

Communication and outreach campaign

The 2024 Population and Housing Census depended not only on technical and operational preparation, but also on informing and raising awareness among citizens about the importance and forms of participation in this process. For this reason, the Kosovo Agency of Statistics (KAS) developed and implemented a comprehensive public outreach campaign, which aimed to inform and mobilize all citizens of Kosovo.

Being a large-scale and far-reaching project, the public communication and outreach campaign played a key role in its preparation and implementation. Through a well-structured strategy and comprehensive activities, this campaign ensured that citizens were informed, engaged and aware of the importance of participating in the process.

Campaign objectives

Some of the objectives of the communication and outreach campaign were:

- Informing citizens about the importance and process of the Census,
- Encouraging active participation from all social and ethnic groups, including marginalized communities and the diaspora,
- Ensuring transparency for the Census process and building public trust, and
- Creating a communication platform to address citizens' questions and concerns in real time.

Information platforms and channels

KAS has used a wide range of platforms and channels to ensure that the campaign messages reach every citizen of Kosovo, including:

- **Dedicated website:** within the official website of KAS, a specific space (section) for the Census was created, which provided accurate, fast and complete information to citizens, the media and all others involved in the process.
- **Conferences and public debates:** KAS organized weekly conferences, where the challenges and progress of the process were presented. These events also served as a platform to answer questions and concerns of the media, promoting full transparency.
- **Media:** articles, interviews, and video messages broadcast through print, electronic and social media were key elements of the campaign. Videos with well-known personalities,

including the President, the Prime Minister and prominent figures from the fields of culture, sports and the diaspora, encouraged massive citizen involvement.

- **Outreach events:** Over 160 events were organized in all municipalities of Kosovo, including schools, universities, colleges and other institutions. These activities focused on directly raising awareness among citizens.

Informational materials and creative events

To reinforce the campaign message, KAS distributed a series of informational materials, such as:

- Leaflets, posters and information letters,
- Advertisements and personalized messages through social networks, and
- Sending informational messages to citizens' mobile phones.

Medias

One of the most important functions of the media is to disseminate information in a rapid, accurate and comprehensive manner. In the case of Census, the media were responsible for informing citizens about the purpose, importance and manner of conducting the Census. KAS cooperated closely with all types of media, including print, electronic and television, where KAS reached agreements with ten television stations to broadcast informative video messages in four languages: Albanian, Serbian, Turkish and Roma. Through these messages, which were broadcast for three consecutive months, citizens from all communities were informed about the enumeration procedures and the importance of their participation in the Census.

Fieldwork

During the Census, fieldwork was a complex and carefully organized process to ensure that the data collected were accurate and comprehensive. This process involved close cooperation between KAS teams, field enumerators, local supervisors and other relevant institutions.

Before the enumeration began, interviewers were extensively trained in the use of technological equipment and in the implementation of interviewing methods according to international standards. Devices such as tablets and laptops were equipped with customized applications for data collection, which facilitated the process and increased efficiency.

An essential part of the success of the process was the organization of logistics. Technological equipment, auxiliary materials and necessary supplies were distributed in a coordinated manner throughout the territory of Kosovo. KAS provided technical and operational assistance to enumerators and supervisors, ensuring an uninterrupted flow of fieldwork.

Interviewers visited every household and individual in all urban and rural areas. The process involved collecting demographic, economic and social data through face-to-face interviews and the use of digital maps to locate each enumeration unit. The integration of a Geographic Information System (GIS) enabled accurate coverage and continuous progress monitoring.

To support the enumeration process, approximately 3,500 tablets and 900 laptops were used, which were configured and prepared by KAS staff. The tablets were used by enumerators in the field for direct data collection, while the laptops were used for quality control, monitoring and technical support by supervisors.

Throughout the process, dedicated support centers provided technical assistance to interviewers and monitored the progress of the work in real time. Any technical or organizational problems were addressed immediately to ensure that the process continued without interruption.

After data collection was completed, the recorded information underwent a detailed checking and verification process to eliminate errors and fill in missing data. This phase ensured that the final data was accurate and reliable for analysis and publication.

Post-enumeration Survey (PES)

The Population Census is the most expensive operation and consists of a series of complex interrelated steps in the national statistical system. It is universally acknowledged that the Census is not perfect and that errors can and do occur at all stages of the census operation.

The Kosovo Agency of Statistics (KAS) conducted the Post-Enumeration Survey (PES) to assess the coverage and content errors of the 2024 Kosovo Population and Housing Census, as recommended by the United Nations Principles and Recommendations on Population. The PES was conducted in full compliance with international guidelines on PES. The survey was conducted by applying the principle of independence from the census process.

The main objective of the PES was to measure the level of national coverage (under- and over-counting) and content errors in the 2024 Census.

Errors in Census results are classified into two general categories - coverage errors and content errors. Coverage errors are errors that arise due to omissions or duplications of persons or housing units in the enumeration.

The 2024 PES questionnaire includes questions to determine whether each re-interviewed person belongs to the target population and to determine the place of residence of each person at the time of enumeration. The questionnaire collects information about the demographic characteristics of each individual to measure response error. The estimates are based on the Dual System Estimation (DSE) methodology.

Based on the findings of the PES, the data from the census are reliable, complete and comprehensive.

A comprehensive special report on the PES is available on the KAS website.

Comprehensiveness and quality of data

Ensuring complete coverage and maintaining high data quality were key priorities for KAS during the Census process. This process was essential to ensure that demographic and social data were complete and accurate, representing all communities and geographical areas of the country. Although the Census faced various challenges, including the fragile political context in some northern municipalities, KAS managed to ensure broad coverage across the entire territory of Kosovo. The use of innovative strategies and modern technologies played a key role in overcoming obstacles and ensuring the quality of the data collected.

One of the most important successes of the Census was achieving high coverage of housing dwellings in Kosovo. This high level of coverage testifies to KAS's commitment to ensuring fair representation of the entire resident population. Such extensive coverage was the result of rigorous monitoring and effective field management, which enabled overcoming logistical and political difficulties in some areas, especially in the northern municipalities. In these areas, due to political tensions and boycotts by the Serb community, coverage was not complete. However, KAS developed additional mechanisms to reduce gaps and ensure that the Census met international standards for statistical coverage.

Also, the assessment of the progress of the Population Census process was particularly emphasized by the UNFPA and UNECE mission at the meeting with local and international stakeholders held at the end of April 2024, by highlighted some important conclusions:

- The 2024 Kosovo Population Census was assessed as a highly organized process.

- The process was in full compliance with international criteria and standards.
- KAS demonstrated transparency and professionalism throughout all phases of the Census.

The engagement of international experts directly impacted the success and legitimacy of Census 2024. The experts ensured that all aspects of the project were in line with global best practices, increasing the credibility of the census data.

The independent observation and assessment of international experts helped build public and stakeholder confidence in the Census results. In addition, KAS implemented a differentiated strategy for the Census in the field, engaging additional resources in those areas where coverage was expected to be difficult. This included the use of a well-trained team of interviewers and observers, who were equipped with in-depth knowledge of local challenges and political sensitivities.

Despite the inherent challenges associated with such a process, evaluations to date indicate that this process has been successfully conducted and will continue to provide a strong foundation for the future.

Territorial division

In the framework of the preparations for Census 2024, one of the fundamental components was the creation and updating of the Enumeration Areas (EAs). These areas constituted the organizational basis for the efficient, accurate and comprehensive collection of data. Through technological improvements and structured divisions, KAS managed to ensure a complete coverage of the country's territory and a standardized process for the Census.

Enumeration Areas are the geographical divisions that help organize and distribute resources for data collection in the field. The accurate mapping and updating of these areas is a complex process, but vital for ensuring a successful census. For Census 2024, KAS updated over 5000 enumeration areas from 2019 to 2022, adding new areas and codifying each dwelling and household. This update enabled better organization of field work and ensured that no dwelling or household was left uncounted.

IT and GIS in the Census process

The use of Information Technology (IT) and Geographic Information Systems (GIS) has played a crucial role in modernizing, automating and ensuring data accuracy.

IT has provided the technical basis for data management, collection and processing, including:

- CAPI in data collection,
- Various Guides for Enumerators, Supervisors and the Center,
- Monitoring System,
- Logistics System,
- Payment System,
- Data Validation,
- Hardware Infrastructure,
- Cyber Security,
- Official Census Website,
- Backup Systems etc.

GIS has been widely used to create and maintain digital maps covering the entire territory of Kosovo. GIS has helped to divide the country into enumeration areas, which have been used to plan and distribute tasks to enumerators, has allowed monitoring of enumeration progress in real time through GPS mobile/tablet devices.

GIS has supported spatial analysis to identify areas with high or low population concentrations and to compile reports for decision-making.

Divisions of areas and codification of dwellings

Another important achievement of this process was the creation of new area divisions and the codification of dwellings. Each dwelling, regardless of its size or purpose, was given a unique code, which facilitated organization and accuracy in enumeration. This codification system ensured that

- Every dwelling and household was included in the process,
- Increased efficiency in data collection and processing, and
- Was able to cope with the complexity of changes in structures and populations, creating a more accurate and comprehensive database.

International technical assistance

International technical assistance included specialized support from foreign experts and international institutions that brought experience and technical knowledge to the implementation of the processes of the Census. In this context, international experts provided assistance in key areas such as: designing technological systems and infrastructure, human resource management, staff training, and developing data collection and processing methodologies.

An important aspect of technical assistance is the provision of sustainable and continuous support throughout the project implementation period. The Population Census is not an activity that can be completed within a short period of time. It requires continuous monitoring, adaptation and improvement of the methods and techniques used.

Due to the lack of a clear and precise definition of the date for the Census, which is usually set 2-3 years before its implementation, as a condition for providing international technical assistance, KAS failed to provide international technical support for the project. During 2019 and 2020, KAS benefited from international technical assistance through short missions (3-5 days), which were focused on the drafting of several strategic and methodological documents. This support was provided by organizations such as Eurostat, UNFPA and the World Bank.

In the budget foreseen for the project, an amount of approximately 1.2 million euros was calculated for international technical assistance, which included the areas of management, methodology, training, communication, information technology (IT), Geographic Information Systems (GIS) and analysis. However, due to the fact that these activities were covered by internal KAS staff, these funds (1.2 million euros) were not allocated by donors and, consequently, were not used for the planned technical assistance.

Data dissemination

Census 2024, as a broad and complex process, includes multiple technical and organizational phases that ensure the collection, verification, processing and dissemination of data, meeting the highest international standards in this field. An essential component of this project is the effective and comprehensive dissemination of data, which aims to meet the needs of various users, including government, academic institutions, international organizations and ordinary citizens. With a high commitment to transparency, inclusiveness and quality, this project will provide a valuable wealth of data for the future development of Kosovo and for strengthening data-based decision-making.

After completing the field data collection, Census 2024 moves to the data processing phase, where their quality and integrity are ensured. During this period, the data will be checked to ensure accuracy and consistency across different sources. Statistical methods are then used to complete inaccessible or incomplete data, ensuring that the final result reflects reality. And, finally, strict protocols are implemented to ensure that the data meets the highest international standards.

The dissemination of data from Census 2024 will be done through various channels that aim to empower access to all interested groups. Detailed reports that include analysis of population, demographic structure, economic characteristics and housing will be published in printed form. These documents will be distributed to central and local institutions, libraries, academic organizations and the media to ensure a wide and comprehensive access. In addition, all interested parties will have access to the interactive digital platform, which will be available to the public. This platform will enable users to search and personalize data according to various parameters, such as age, gender, economic status, residence and others. The data will also be available for download in usable formats such as PDF and Excel, facilitating further analysis and use for research, planning and policy-making purposes.

Given the linguistic diversity of Kosovo and the need to communicate with an international audience, all publications and data will be available in three languages: Albanian, Serbian and English, ensuring equal access for all.

The dissemination of data from Census 2024 aims to provide a strong basis for data-based decision-making, foster scientific research and increase public transparency. The Census results will be an essential source for the design of government policies in areas such as education, health, urban development and social welfare, ensuring that public policies are based on accurate and up-to-date data. Academic and research institutions will have the opportunity to use the data to conduct in-depth analyses in various fields, such as demography, economy, social development, etc.

The data will be accessible free of charge to all citizens, thus increasing transparency and encouraging the active participation of citizens in decision-making processes and public discussions on the country's development.

Online platforms

KAS will disseminate data online through an advanced technological infrastructure that guarantees transparency, access and use of official statistics by the public and national and international institutions. This will be achieved using an integrated approach that combines several modern platforms and technologies.

ASKdata: is a digital platform developed by KAS to enable the disseminate statistical data in an interactive manner. This platform offers users easy and personalized access to official statistics, including: Interactive statistical tables, dynamic graphics, open APIs for integration with other systems, etc.

WebGIS for Geospatial Data Visualization:

WebGIS is a system that enables spatial visualization of statistical data and is used to assist in the population census process. Through WebGIS, population census data can be displayed on

interactive maps, including; interactive display of maps with locations of census units, integration of census data and other statistics.

Publications and Metadata:

KAS will publish special thematic publications and will document the enumeration process through the SIMS 2.0 metadata system, such as: clarifications on the use and limitations of data to ensure transparency and clarity, limitations and interpretations, harmonization of data according to international standards, etc.

SDMX for data exchange:

The SDMX (Statistical Data and Metadata Exchange) format is an international standard for the exchange of statistical data between institutions. The main benefits of using SDMX include: providing a unified format that facilitates international data Exchange, the data exchange process becomes faster and less complicated due to automated integration, and standardization and automation minimize the possibility of errors during data exchange.

eDAMIS for Data Exchange with Eurostat:

It is a platform used by Eurostat for the exchange of statistical data. The benefits of using eDAMIS include: statistical data are sent in a secure and encrypted manner, Kosovo meets its reporting obligations to Eurostat, and support for certification and monitoring of the quality of the data submitted.

Request for specific data

Since the Census 2024 data includes sensitive information, they are treated with the highest level of confidentiality.

Based on the Law on Official Statistics, the Law on Census and the Law on the Protection of Personal Data, the data collected by Census 2024 are confidential data. This means that any information that can identify individuals or households cannot be made public or used for purposes other than those approved by law. KAS guarantees that all data is processed in accordance with these laws and relevant guidelines, thus preserving the integrity and privacy of each individual.

KAS has established a clear process for submitting requests for specific data: users must submit a formally documented request, clearly describing the purpose of using the data, the type of data requested and the analysis expected to be performed.

After submission, the request is reviewed by the KAS team to ensure that the requested data does not violate any confidentiality rules and is in line with the permitted purposes of use. Finally, KAS prepares the requested data by anonymizing it and ensuring that no information that could identify specific individuals is included. Only general/aggregated data can be submitted.

To ensure that any processing of personalized data follows the highest standards of ethics and security, KAS has issued a series of guidelines and procedures that must be respected by all data users. These guidelines include details on how to anonymize data, restrictions on their use, and reporting of the final results of the analyses performed.

Requests for specific data play an important role in promoting scientific research, developing public policies, and improving decision-making in various fields. ASK remains committed to balancing transparency and confidentiality in the handling of Census 2024 data. Through a regulated process for requests for specific data, KAS ensures that the data collected is used for useful and valuable purposes for society, without violating the right to privacy of individuals.

CHAPTER 5

POPULATION ACCORDING TO THE POPULATION CENSUS AND ESTIMATION IN THE FOUR NORTHERN MUNICIPALITIES

Population Estimation for the Four Northern Municipalities of Kosovo

The Kosovo Agency of Statistics (KAS) has conducted a **Population Estimation** for the four northern municipalities of Kosovo: Leposavic, Zvecan, Zubin Potok and Mitrovica e Veriut (North Mitrovica). These municipalities are predominantly inhabited by the Serb community which, to a considerable extent, boycotted the census process as a result of calls for a boycott by Serbian political entities.

This estimate was conducted in close cooperation between KAS and international experts, based on international practices and standards for population estimation.

The results of the Population Estimation for these municipalities will be included in the total population of Kosovo, which will officially be taken as the total population of Kosovo (05 April 2024), thus providing a complete and accurate picture of the country's demographic structure.

Fig. 1- Population by age group in Kosovo

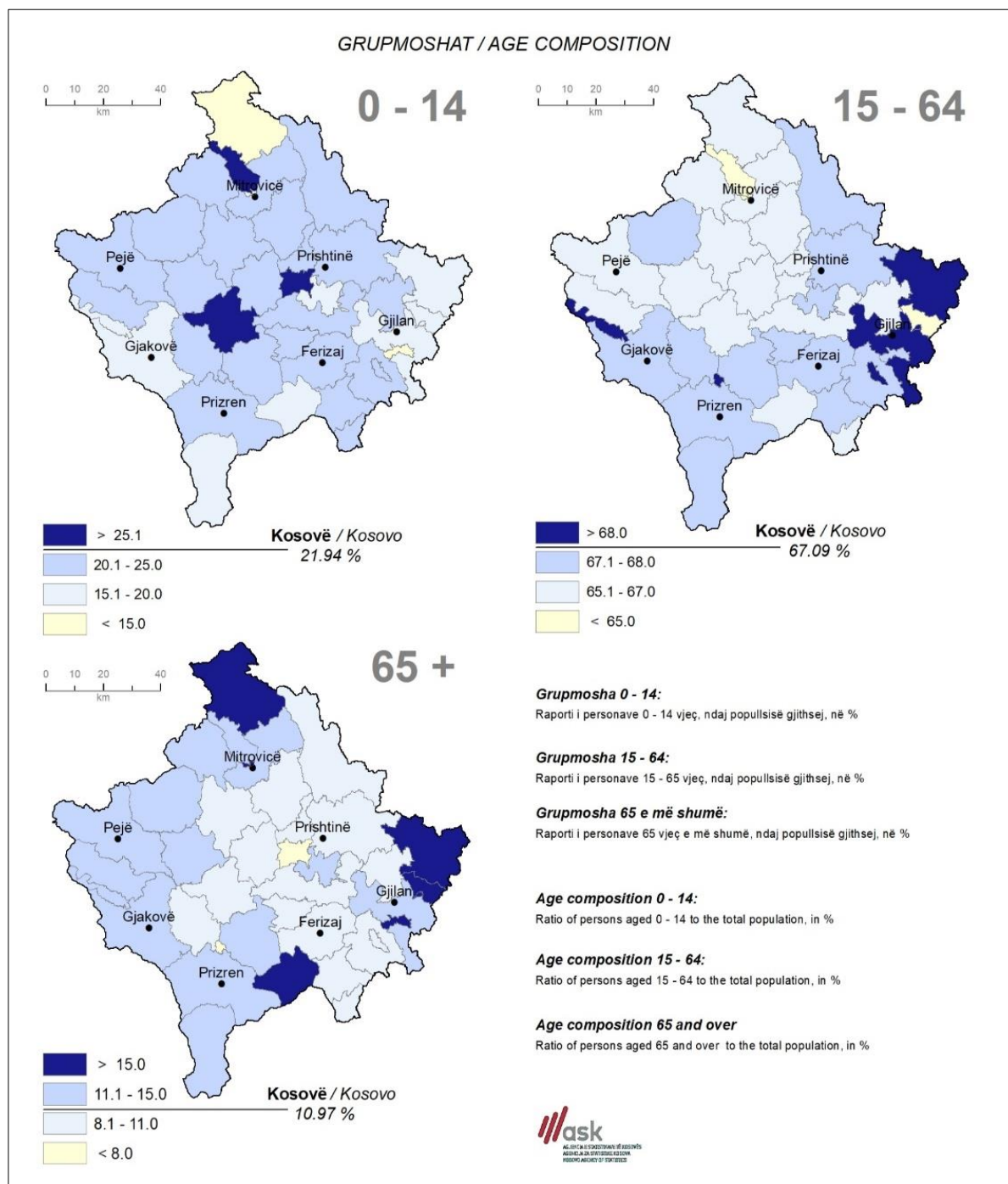


Fig. 2 - Population by gender ratio in Kosovo

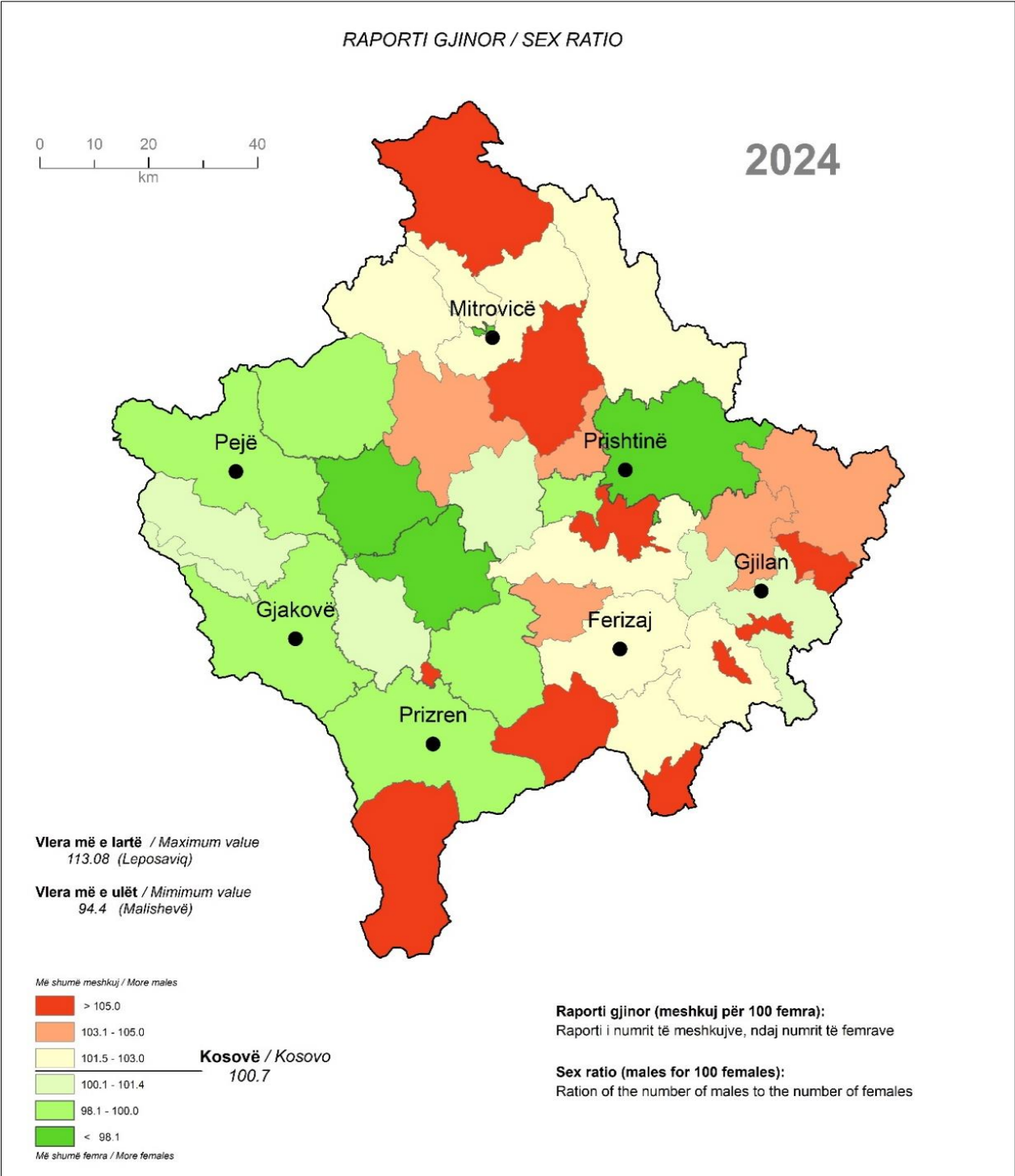


Fig. 3 - Urban population in Kosovo

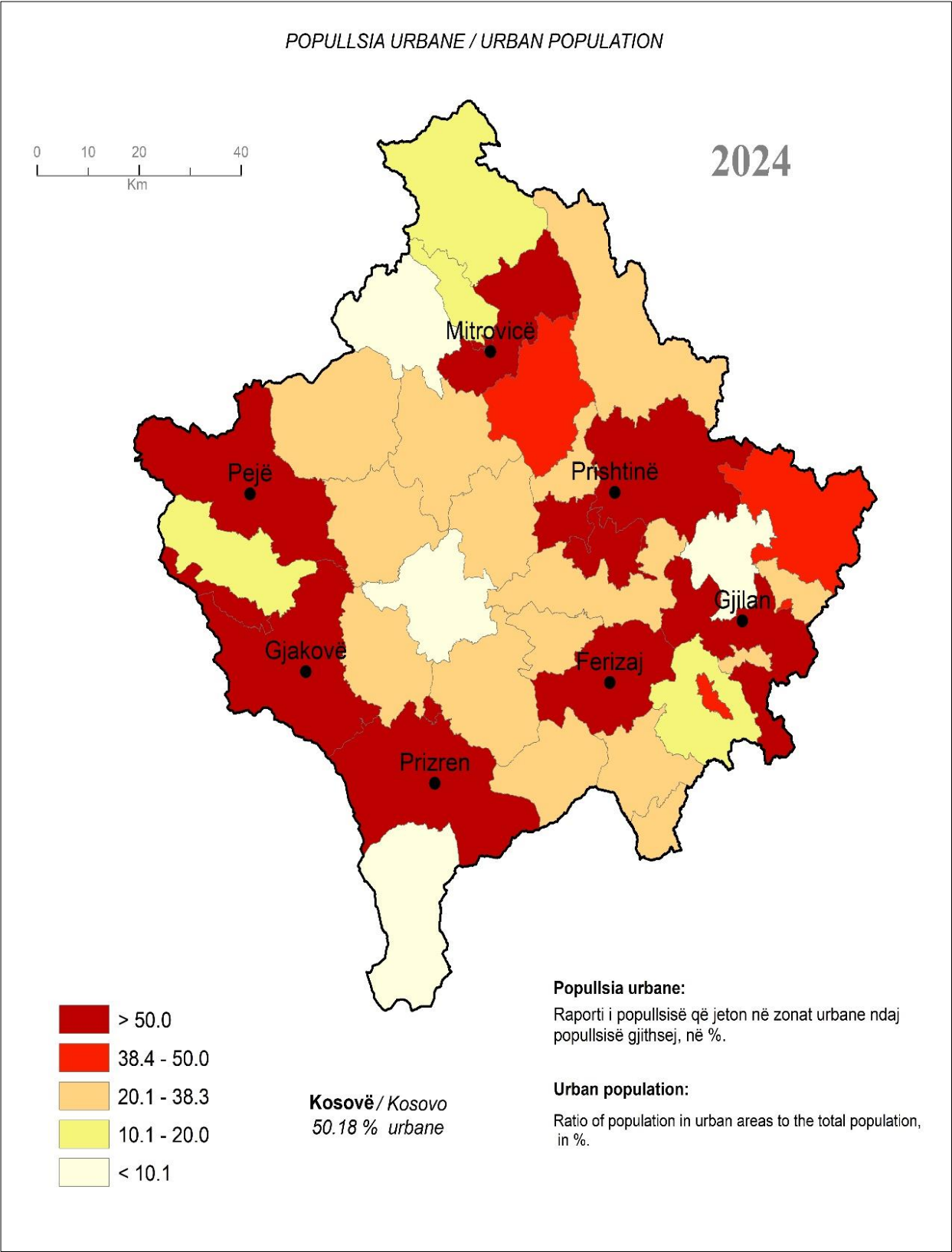


Fig. 4 – Population density in Kosovo

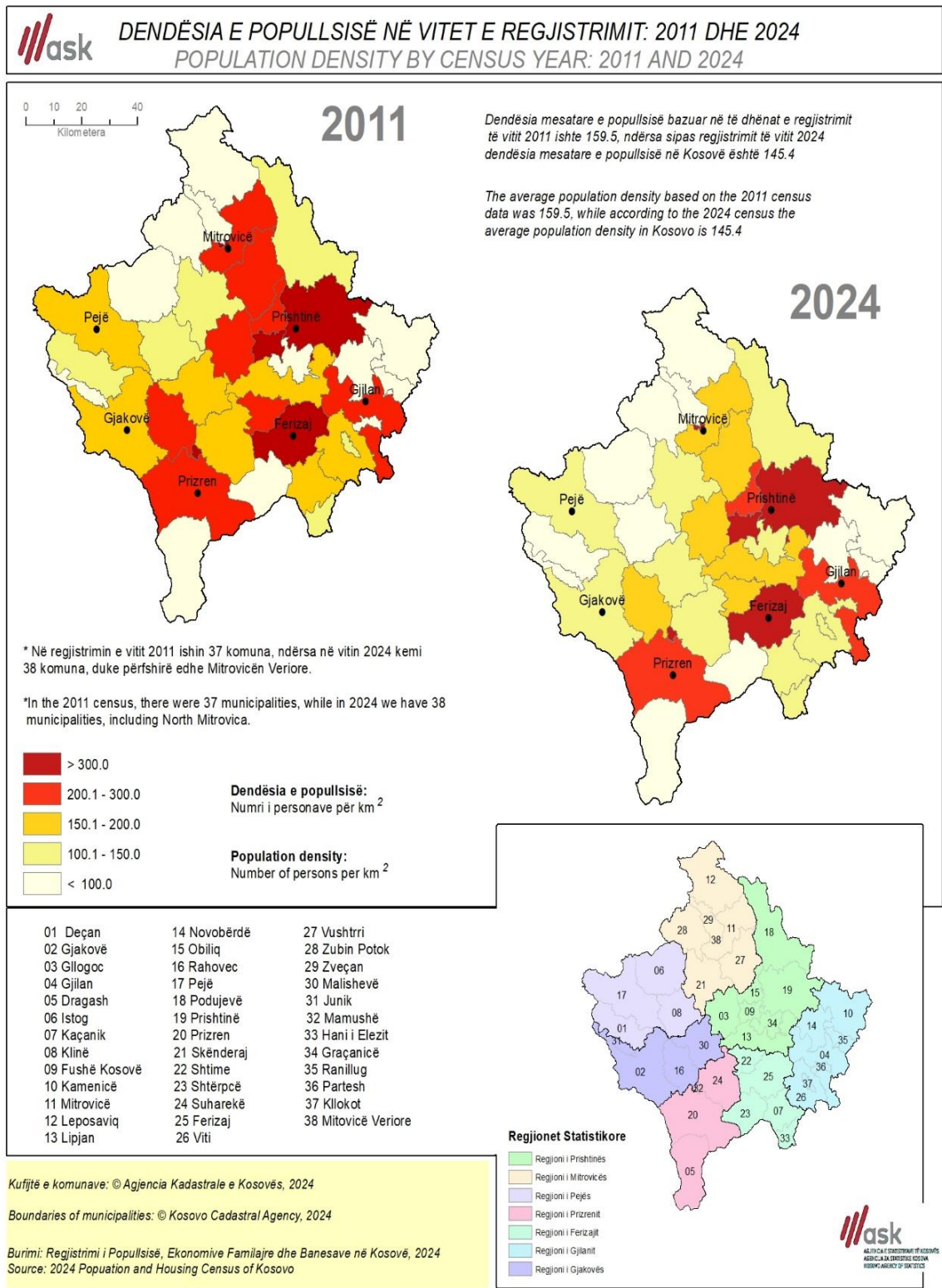
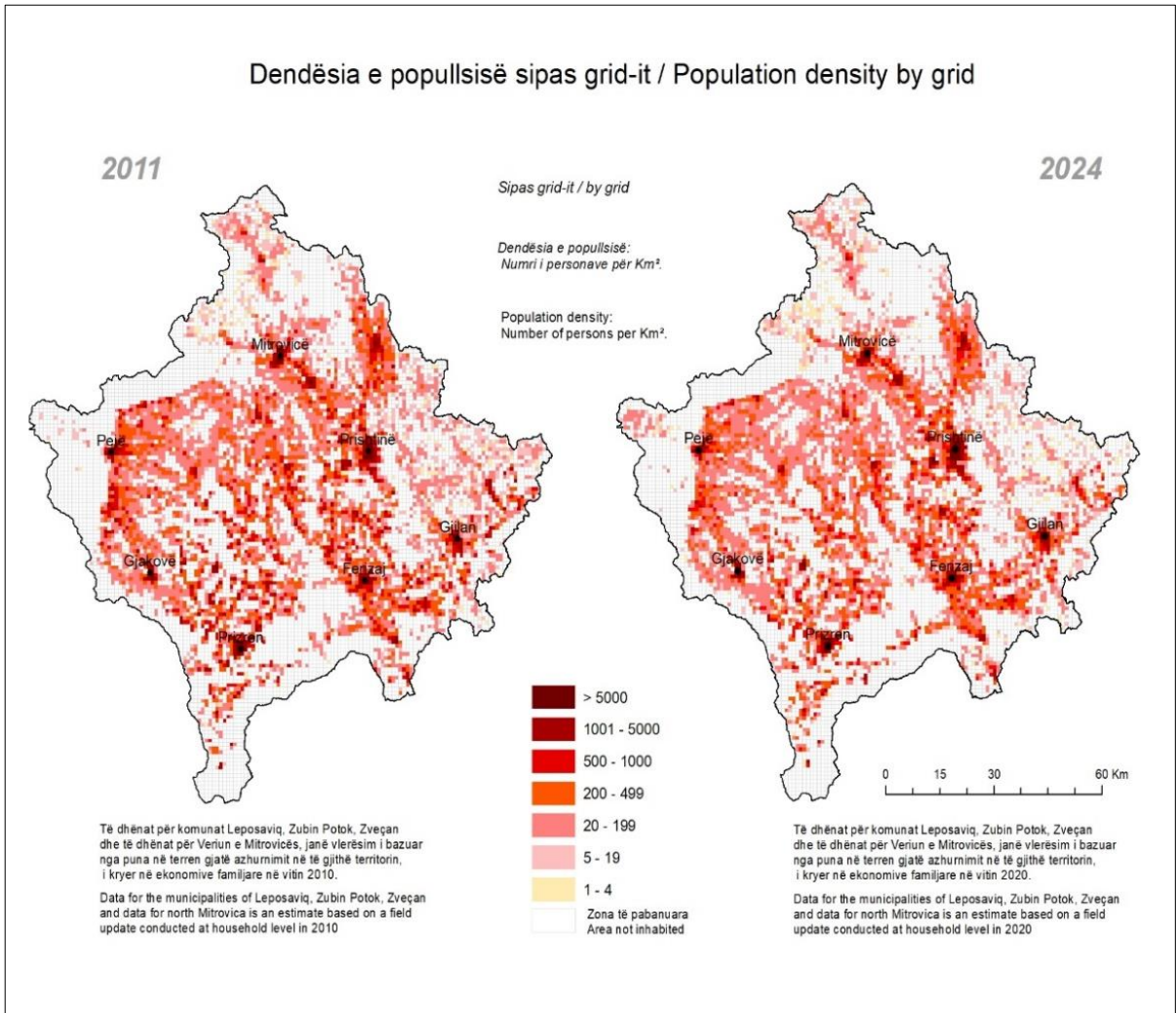


Fig. 5 – Population density in Kosovo according to the grid
